Report of work Federation has undertaken to return refugees who have died at sea home

10 October 2015

Refugee boat sinking mother and 5 children drown off Greek Coast.

Muhammad Ahmad Father of the children told IFIR by phone "I fled from Kirkuk-North of Iraq on 10 of October with my family my wife and five children. We paid 12 thousand dollar and from Turkey Bodrum. We were placed on a small boat with 19 others on the 16 of October at 10PM"

Father also said "The Man who drove the boat, stopped the boat when we came close to Kos Island. As he stopped the boat water flooded in. We were 600 meter from the Island the boat sank and my family were swept into the sea. They haven't yet found the bodies of my wife and one child. The Greek police are still looking for their bodies" Ari Jalal representative of IFIR the Sulaimanya branch Said" We have contacted the Iraqi embassy in Greece, KRG Government and Shadan Abdelkarim from the Department of Migration and displaced people from Kurdish region with full details of the victims to request the return of their bodies to Kurdistan" >continued on page 4



Open the borders Immediately to Refugees

IFIR held a demo in front of the Finnish Parliament



In Friday 19 of February a number of Iraqi Refugees held a demo in front of the Parliament building in Helsinki. The demonstration was called in solidarity with Kurdish public sector workers demands for payment of wages from the Kurdish Regional Government. Rebwar Ariif Secretary of IFIR Finland spoke about the political situation and insecurity in Kurdistan. In particular the plight of public sector workers some of whom had not received wages for six months.. He also spoke against the Finnish Government's forcible deportation policy of Iraqi Refugees.

He summed up by talking about the importance of refugees uniting and working with progressive people and working class activists in Finland to defend the rights of all working people.

1 March Calais solidarity demonstration



On the 1 March at 19.30 activists gathered outside the French institute to protest regarding the treatment of refugees in Calais. Amongst the activists was Dashty Jamal secretary of IFIR. Dashty made an impromptu speech regarding events in the Middle East which have led many of refugees to flee their homes. Dashty told of the terrible conditions in the refugee camps that led many to make the dangerous journey across Europe. Following Dashty's speech the crowd started chanting slogans condemning the French authorities attacks on the refugees in Calais. At the end of the demonstration activists marched round the French Institute. The demonstration finished at 9pm. IFIR slogans: Stop attacking refugees in jungle, Shame on France and EU for letting refugees live in Stone Age conditions, Refugees in Calais are victims of war & barbarism

Refugees are welcome here

Dashty Jamal's open letter to the European Summit and to the President of the European Council

Dear Donald Tusk and Representatives of the Member States in the European Council,

As a continuation of your previous meeting relating to the refugee crisis, another meeting is supposed to be held in Brussels on 17 and 18 of this month to discuss ways to stop refugees from reaching Europe. Those refugees have escaped the war, they are the victims of proxy war by the big powers in their countries, and they are putting themselves at risk, by crossing minefields and dangerous seas. Most of them are children, women and older people. They leave their homes and work because they are forced to by war and by the mafia in their area. Europe will bear a big responsibility for the consequences if they put the fate of those refugees in the hands of a dictator like Erdogan and his brutal regime; this will



be a disgraceful episode in the post Second World War history of Europe.

Turkey is not a safe country even for its own citizens, political activists, civil activists and journalists, so how can the fate of these refugees be handed over to Turkey? Rather than protecting democracy and human rights, Erdogan's regime every day comes closer to being an Islamic dictatorship. By appealing to Turkey to solve the refugee crisis, the EU is turning a blind eye to Turkey's crime against Kurdish civilians and political activists, and to its help for the terrorist

groups in Syria such as Al-Nusra and ISIL. Working with Turkey in such a way puts a big responsibility on the EU. Removing the borders between most EU member states was a great gain for Europeans, but building high fences with barbed wire and using Special Forces to close the borders does not benefit the EU. Spending billions of Euros on controlling the borders will not stop the refugee flow, it will be much better if the money is spent on helping those refugees to resettle and on improving their life.

Refugees always participate actively in all social fields such as health and the economy, so it would be better to help them rather than working against them with the bloody Islamic regime in Turkey which helps terrorists in Syria.

Most of the refugees are from Iraq, Syria, Afghanistan, Lebanon, and African countries. They are victims of wars originally ignited by the imperialist powers like US and Russia (under the guise of fighting terrorism or the Syrian regime) for their own interests and to maintain their favoured balance of power. The regimes in those countries will not take responsibility for their citizens; in fact they are the source of insecurity for their own people. Sectarian fighting and ethnic conflict are the main reasons for the refugees to leave their homes and seek shelter in Europe for a better life.

If the European countries want to find real solutions for this crises, they will have to deal with the causes which created the refugee crises. Increasing the border measures will not solve the crises but will make it deeper. Forcibly returning people will not stop refugees from coming to Europe, but it will make smuggling networks wider, and the smugglers will still make the refugee use dangerous routes to reach Europe. Such policy in treating refugees so badly and playing with their fates and their rights will not be accepted by Human Rights groups and humanitarian movements even in your countries.

As a part of our responsibility we - International Federation of Iraqi Refugees (IFIR) - are sending you this letter, asking you to treat refugees in a responsible manner, and not to act in a way that damages the prestige of the EU and its laws or humanitarian considerations. Therefore we are asking for:

1. An end to the policy of imperialist wars of division in the Middle East and North Africa; condemnation of the NATO, Russian and Chinese military interference in the area, and end to their support for groups affiliated to them, because it is their war which created instability and poverty leading to a mass refugee exodus.
2. No forcing of the Turkish government to take back refugees; Turkish government to be put on trial for the mass killings of Kurdish people and their other crimes against political activists, and for their support of jihadi groups such as Al Nusra and Al Qaida.
3. Opening of the borders for the refugees who are victims of war, in order to save them from death; equal allocation of refugees across Member States in line with Member States' responsibilities, and protection of refugees from racism and from assault by fascists.
4. Activation of the UN in the war-torn countries in order to help IDPs and refugees and to oblige the EU to recognise the refugees' rights and provide them with assistance.
5. Swift steps by the EU to enable civil society groups and refugee organizations to help the refugees with food, health care, clothes and shelter without discrimination by ethnic group or religion.
6. Planned resettlement of the refugees in the receiving countries, with no social or economic discrimination against them. Support for social movements and organisations that work to establish secular systems in the Middle East and North African countries. European countries must take equal responsibility for implementing these tasks

14 November 2015

Adeb Abdul Kader from Dooz left Kurdistan to travel to Turkey on the 14 October 2016. Adeb was abandoned by the people smugglers in Azmir, Turkey. Sadly he was found dead a few days later. Adeb was a peshmerga fighter. He lost his sight in a car bomb in Kirkuk 14 May 2005. Adeb's body was returned from Istanbul to Erbil airport on the 14 November. The return of Adeb's body was supported by Adeb's family and IFIR.

22 January 2016

Ari Jalal, representative of the office of Kurdistan branch of IFIR, told the secretary of federation: 'we have received information regarding another boat sinking on the Aegean sea. The boat sunk near Izmir. The Police went to help them but only rescued 25 refugees. 23 of them are from the Kurdish Region. They have however found a further 13 dead bodies. The refugees are currently in Izmir hospital.

Three people accused of people smuggling have been arrested.

Names of the dead people found: Zhwan Hiwa Tofiq, Zhala Hiwa Tofiq, Zhila Hiwa Tofiq, Xadija Muhammad Aziz, Sima Qasm Usf, Shapol Qasm Usf, Xanzad Qadr Taha, Payam hadi Abdulrahman, Miran Hadi Abdulrahman, Bayan, Sahand

Name of those who were not found: Bahar Ismail Xzr, Shako Ismail Xzr, Darya Qasm Usf, Kany Qasm Usf, Aub Ibrahim, Rezan Tofiq, Amir Aub Ibrahim, Ahmad Aub Ibrahim, Avin Aub Ahmad, Aub Ibrahim, Azhin Aub Ibrahim, Ismail Usf Ali, Rwqya Xzr Hamasur, Hogr Qasm baba.

All the bodies found will be returned to Kurdistan in the near future.

The morning of 24 January

Ari Jalal, reported that: "at 07:45am on 24.01.2016 six dead bodies were sent via Athens airport to Amman airport and then to Sulaimany airport. The names of the dead migrants: Salar Muhammed Qadr, 2. Abdulqadr Muhammad Qadr. 3. Aya Salar Muhammad. 4. Ahmad Salar Muhammad. 5. Usf Salar Muhammad 6. Aub Salar Muhammad "

The Federation waited at Sulaimanie airport with the relatives of the dead people. There were also several reporters from the media at the airport Ari reported after returning the victims to their family homes and or the mosque they were all buried in Panja Ali graveyard near Lailan town."

The evening of 24 January

On the evening of 24.01.2016 at 06:10, we were informed by a citizen named Hiwa that another boat had sunk near one the Greece islands, in which some of his relatives had died. Following this report we contacted one of the rescued people and he narrated the event in this way:

"on the 23.12.2015 18 refugees were sailing from Didim island, Turkey to Larus island, Greece. When the boat ran into trouble and started to sink. 6 of those who drowned were from the Kurdish town Kirkuk their names are: Salar Mhammad Qadr, 2- Abdulqadr Muhammad Qadr. 3. Aya Salar Muhammad. 4. Ahmad Salar Muhammad. 5. Usf Salar Muhammad. 6. Aub Salar Muhammad) >continued on page 5

Only Salar's wife (Laila) was rescued. The body of Aub still not found.

A further four people from Sulaimania, originally from Mariwan city in the East of Kurdistan, died. Their names were: Haibat Fayzy (head of the family), Gulnar Ahmed, Hana Haibat, Kaziwa Haibat. They were members of one family. IFIR supported and helped by (Mam Hazhar and Pershraw Mohammed) from Athens a Kurdish to bring back their body on 31 January 2016 to Sulamania Aport.

Dashty Jamal Secretary of IFIR, Ari Jala representative of the office of Kurdistan branch of IFIR, Mr Dana Mohamad Saied representative of Communication of Sulaymania Airport waited at the airport with family members until the bodies arrived. Four more people a family from Afghanistan also sadly died.

31 January 2016

Three bodies returned to Sulaimany airport 26th of February 2016 Ari Jalal, representative of the office of IFIR, Kurdistan Branch, informed the Federation that on the 27th Feb the bodies of a mother and her two young daughters were being returned to Sulaimany airport. The family was travelling to the Greek island of Leros. When unfortunately like so many others the yacht they were sailing on sank. Fifty five others on the yacht were also drowned, of the fifty five only 8 bodies had been found. The yacht sank on the 22 January. The reason for delay of returning the bodies was due to problems identifying the mother and her children as no ID was found with them..Representatives of the federation Kurdistan department were at the airport with relatives to receive the bodies.

5 March 2016 – meeting with Minister of Health

On Saturday 5 of March Ari Jala met Dr Rekawt Hama Rashed of Minister of Health. They spoke about the issue of the many unidentified bodies of drowned Kurdish refugees. The Minister of Health promised to introduce a process to identify the bodies.

11 December 2015 IFIR representatives distributed food and supplies to the Displaced people in Ashty camp (Means peace) to more than 2000 families. IFIR would like to give special thanks to Waqufasunni organization for donating funds which enabled IFIR to gather the supplies needed to support the displaced people of Ashty.

IFIR also donated medical supplies to Kobani hospital.

Anwar Muslim and Salih Muslim Muhammad co-chairman of the Democratic Union Party(PYD) and Mrs Aishah Afandi met Ari Jalal IFIR representative of branch office Kurdistan to thank him.

Amanj Abdulla Representative of IFIR Kurdistan Branch gave many Interviews with journalists from the media and TV stations. Amanj spoke about: refugee crises; the situation of Kurdish refugees in Europe; The perilous journey many refugees took across the sea.

I am going to speak about the new wave of refugees from Middle East as refugees, not as migrants. And, accordingly explain why they should be accepted and supported.

We are living through a time of chaos that has driven millions of people from their homes across the region. In particular the worse effected by this crises are the people from Syria and Iraq. We have seen scenes of people walking across Europe with nothing but the clothes on their backs. We have seen people with very young children being forced to flee for their lives. Against this background of severe fear and terror to refer to these people as migrants is just wrong and underestimates the terrible situation they are being forced to flee from. An active and powerful organization and movement to campaign for the rights of refugees is necessary and urgently required. This organization should include all human rights campaigners and humanistic activities to challenge the inhumane policies towards today's refugees.

Fleeing and seeking for asylum and a safe refuge is the outcome the violence and imperialistic policy of the US and the Western governments. Iraqi and Syrian Refugees have been forced to leave their homes due to lack of security, poverty and violent conditions which they have not chosen but have been imposed on them.

The warmongering policy of the American, European and Russian governments has directly led to military and political intervention in some counties in the Middle East and North Africa. This policy has caused carnage; death of hundreds of thousands; havoc; displacement and devastating any trace of modern and urban society in those countries.

I fear that the response of the Western Powers to bombard Syria in retaliation for the murder of Paris' young people by ISIS terrorists will just make the current refugee crises worse. The Federation believes that the major reason for the displacement of people and becoming refugees and asylum seekers are governments that drive their countries into war without regard for the welfare, equality and security of people. The Sea is more dangerous than they expect and it takes their lives very easily.

For this reason today we speak against our corrupt government and people smugglers on the borders. If people had a good life, freedom and bright future, they would not risk their lives in the dangerous waves of the sea. We call on the Kurdish authorities to think about how to make life better at home instead of thinking about how to bring back the dead bodies of our young.

We ask is society a place for assembling money and taken other people's property? And escaping people as a consequence of this injustice? Or is it possible to be a better place for us all? The last option is our hope.

IFIR estimate that 388 people died in the Aegean Sea in 2015. In 2016 from January – February 134 people have already died attempting to cross the Aegean Sea, yet only 84 bodies have been recovered the rest remain in their very sad watery grave. In the last year 200,000 of Iraqi citizens have migrated to Europe and every day the number is increasing. It is this government's duty to:

- Respond to the people's questions and make their lives better.
- Returning the body of victims to their country.
- Searching for the lost bodies.
- With the representative of the federation indemnity those families to whom lost a member of the family.
- Force Turkish government to arrest those smugglers who make money over people's life.
- Mandate United Nations to get the refugees and transfer them to the third country.
- Mandate Europe's Governments to open their borders.

Finally I just want to say don't put you or your families future at risk by gambling your life in the sea.

Using force against refugees must be halted immediately

Today there is another meeting of EU countries in Brussels to stop refugees fleeing to EU. European leaders' continue to use Turkey as their border guard to stop refugees fleeing war from travelling to safety in Europe.

This is a dangerous and deliberate ploy to avoid responsibility to people fleeing war.

Dashty Jamal Secretary of International Federation of Iraqi Refugees-IFIR said: "The tragedy of the refugees' dying in groups on the borders of Europe, in the Aegean and Mediterranean Seas, is a direct consequence of the policy of closing the borders to people whose livelihoods and place of residence turned into battlefields, amidst civil war, unrest and insecurity"

"The European countries and the West whilst they always talk about human rights have provided no realistic solution to prevent the wave of death among the refugees. They want to use NATO, Frontex and other forces for the victims and women and children, ignoring the fact that they are among the main reasons for the catastrophes that led to the refugee's exodus from the Middle East. The majority of the refugees from Syria, Iraq, Afghanistan, and North Africa are victims of the direct political and military involvement of the US and European countries. It is due to their support for inhuman, repressive militia systems in the Middle East, which are covered with the dress of democracy"

"The warmongering policies of the American, European and Russian governments directly led to military and political intervention in counties in the Middle East and North Africa. This policy has caused carnage; deaths of hundreds of thousands; havoc; displacement and has devastated any trace of a modern or urban society in those countries. People have no choice but to flee."

IFIR is asking EU Leaders to:

- Stop playing with the lives of victims of your wars
 - Open the borders immediately to refugees to rescue and protect them from disasters, racist and fascist aggressions
 - Prevent the wave of refugees and destitution. This depends primarily on putting an end to the fighting and military involvement of the US, the West, Russia, China and other forces and regimes supporting the two main fronts. The European countries and west must give up the policy of supporting the repressive regimes which resulted in social unrest and insecurity.
- IFIR condemns any forcible deportation policy The European governments must share responsibilities for meeting the needs of refugees
